### RESOLUTION OF THE GOVERNING BODY OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA

RESOLUTION NO: 12-TM-12

**BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA, THAT**

**WHEREAS**, this organization is an Indian Organization as defined under the Indian Reorganization Act of June 18, 1934, as amended, to exercise certain rights of home rule and to be responsible for the promotion for economic and social welfare of its Tribal Members; and

**WHEREAS**, the authority contained in Public Law 93-638, as amended (Indian Self-Determination and Education Assistance Act), provides Indian Tribes and organizations to plan, organize and implement its own social and economic programs; and

**WHEREAS**, the Te-Moak Tribal Council is currently in contract with the Bureau of Indian Affairs to provide services in the Tribal Enrollment Services Program to the Indian Communities of Elko, Battle Mountain, South Fork and Wells and other locations within the exterior boundaries of the continental United States; and

**WHEREAS**, pursuant to the Te-Moak Tribe of Western Shoshone's Constitution, Article 1, Tribal Membership is a constitutional requirement of the Tribe to provide applications to eligible members; and


**WHEREAS**, the existing Contract Scope of Work for the Te-Moak Enrollment Services has not changed; and

**THEREFORE, BE IT RESOLVED**, the Te-Moak Tribal Council is requesting the Bureau of Indian Affairs to extend the existing contract of the Te-Moak Enrollment Services Program for an additional two (2) years commencing October 1, 2012 to September 30, 2014, a term of two (2) years.

**BE IT FURTHER RESOLVED**, that the Chairperson or Vice Chairperson of the Te-Moak Tribal Council shall be authorized to affix his signature and to negotiate and execute any and all necessary documents for said extension.
