RESOLUTION OF THE GOVERNING BODY OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA

RESOLUTION NO: 10-TM-18

BE IT RESOLVED BY THE TE-MOAK TRIBAL COUNCIL OF THE TE-MOAK TRIBE OF WESTERN SHOSHONE INDIANS OF NEVADA; THAT

WHEREAS, this organization is a recognized Indian Organization as defined under the Indian Reorganization Act of 1934, as amended, and exercises rights of home rule and is responsible for the promotion of the economic and social welfare and well being of its members; and

WHEREAS, Te-Moak Tribal Council is composed of four (4) constituent Bands, Elko, Battle Mountain, South Fork and Wells; and

WHEREAS, the provision of high quality health care to Tribal members is a matter of vital concern to the Tribe; and

WHEREAS, the Tribe shares common interests and concerns with other Nevada Tribes regarding Tribal Health Care priorities; and

WHEREAS, the Tribe recognizes the importance of speaking with a united voice to the federal and state governments on matters concerning Tribal Health Care; and


THEREFORE BE IT RESOLVED, that the Tribe sanctions and supports the creation of the Indian Health Board of Nevada (IHBN), on which the Tribe will participate as a member; and

BE IT FURTHER RESOLVED, that the Tribe hereby rescinds Resolution #07-TM-15 and authorizes Bryan Cassadore and Paula Brady as the alternate as its designated delegates to serve on the Board of Directors of the IHBN; and

NOW, THEREFORE BE IT RESOLVED, that the Te-Moak authorizes the IHBN to enter, on behalf of the Tribe and the other members of the IHBN, contracts, compacts and/or funding agreements with the federal government, under the Indian Self-Determination and Education Assistance Act, P.L. 93-280 as amended, to perform services benefiting all member Tribes of the IHBN.
